EXPLANATION REGARDING THE INCOME-BASED PARENTAL CONTRIBUTION FOR THE TODDLER PROGRAM

The municipality of Bergeijk will charge you an income-based parental contribution if you are ineligible for benefits under the Dutch Childcare Allowance Act (Wet Kinderopvangtoeslag). The amount of your monthly contribution depends on your income and is based on the VNG advice table (see www.vng.nl). In order to allow us to set the amount of your monthly contribution, please submit the 'Income-Based Parental Contribution for the toddler program' form, and make sure you append the personal income statements for yourself and your partner (if you have one).

Your partner is the person to whom you are married and from whom you are not permanently separated, or an unmarried cohabitee with whom you share a joint household. Your parents, grandparents, brothers, sisters and children are not considered your partners. According to the Participation Act, a single parent is 'an unmarried person who shoulders all the day-to-day responsibilities (including the financial burden) for one child or several children'. If you are a single parent, please provide evidence of your status, e.g. monthly benefit statements or a copy of the divorce settlement issued by a court of law.

Please note that you are not obliged to submit information on your income to us. If you choose not to do so, you will automatically be charged the maximum fee. The amount of the parental contribution will be set for the entire period during which your child attends the toddler program. If there are any significant changes to your income situation (e.g. reduced income), please re-submit the form. If you fail to submit the form in time, you will not receive a refund of the contribution already charged.

The information you provide on your income will be treated as strictly confidential. Your information will not be visible or accessible to third parties.
